### ORDER


**Subject: Appeal made by Shri Praveen Sakhuja under Section 19(1) of the Right to Information Act, 2005**

Shri Praveen Sakhuja vide his letter dated 20.05.2013 has made an appeal under Section 19(1) of the Right to Information Act, 2005 against reply dated 10.05.2013 of CPIO, EIC in relation to information sought by him vide his application dated 01.04.2013.

Vide his application-dated 01.04.2013, Shri Praveen Sakhuja had requested for confirmation, in yes or no, whether six types of rules / instructions / circulars were applicable to the employees of EIC. In response, the CPIO had informed Shri Sakhuja that being a subordinate office, circulars / instructions etc., issued by the administrative Ministry are applicable to the employees.

I have gone through the appeal and observe that Shri Sakhuja has not been precise in seeking information. He has raised a vague query while expecting a precise answer. Shri Sakhuja may note that as EIC has its own statutory rules, instructions / circulars issued by the administrative Ministry are applicable to the extent they are not contrary to the statutory rules.

As there is no denial of information, the appeal made by Shri Praveen Sakhuja stands disposed of. Shri Sakhuja is also advised to be precise while seeking information in future.
