
ORDER



With reference to your request, point-wise information is given below:

1. The applicant is seeking interpretation of Export Inspection Agency (Recruitment) Rules, 1980 as amended from time to time and as such does not qualify under RTI Act. However, these recruitment rules are also available on EIC's website at www.eicindia.gov.in.
2. Dr. A.S. Upadhyay was offered the post of Joint Director (Tech) on deputation basis initially for a period of one year likely to be extended further, vide letter dated 31.05.2013. A copy of letter dated 31.05.2013 which was issued with the approval of competent authority is enclosed.
3. Deputation period of Dr. Upadhyay has been extended for a further period of 2 years w.e.f. 26.06.2013 vide letter dated 10.07.2013 with the approval of competent authority. A copy of above mentioned letter is enclosed.

Terms and conditions applicable to Dr.Anand Shankar Upadhyay on his joining the post of Joint Director (Tech) on deputation in Export Inspection Agency/Council.


1. Period of deputation	The period of deputation of Dr.Upadhyay with Export Inspection Agency shall be initially for a period of one year. The period of deputation is extendable as per the conditions prescribed under normal rules.
2. Pay	During the period of deputation Dr.Upadhyay will have the option either to get his pay fixed in the deputation post under normal rules in operation or to draw pay of the post held by him plus deputation duty allowance in accordance with and subject to the conditions as laid down under Ministry of Finance O.M.No.10/2-3)E/111/60 dated 4 th May 1961 as modified from time to time and such other general or special order issued by the Ministry of Finance in this regard.
3. Dearness Allowance	Dr.Upadhyay will be entitled for DA as admissible to the employees of Export Inspection Agency/Council.
4. CCA & HRA	It will be regulated as admissible to the employees of Export Inspection Agency/Council.
5. Joining time TA transfer travelling	Dr.Upadhyay shall be entitled to TA and joining time, both for joining the post of deputation and on reversion there from to his parent department as applicable to the employees of Export Inspection Agency/Council.
6. Conduct Discipline & Appeal Rules	Dr.Upadhyay will continue to be covered by CCS Conduct Rules as applicable to all Central Govt. employees. However, he shall be covered by Export Inspection Agency (Classification Control and Appeal) Rules 1978.
7. TA & DA for journey on Duty during the period of deputation	During the period of deputation, TA for journey on duty shall be regulated as applicable to the employees of Export Inspection Agency/Council.
8. Leave & Pension	During the period of his deputation Dr.Upadhyay will continue to be governed by the Leave and Pension Rules of the Central Government applicable to him before such transfers. The entire expenditure in respect of leave taken during or at the end of deputation shall be borne by the Export Inspection Agency-Chennai. In latter case, the leave and its period shall be regulated as applicable to the employees of Export Inspection Agency/Council.

9. GPF Benefits	During the period of his deputation, Dr.Upadhyay will continue to subscribe to the provident fund of the Central Government to which he may be subscribing at the time of his transfer, in accordance with the rules of such funds.
10. Medical Facilities	Dr.Upadhyay will be entitled to medical facility under the rules of the EIC.
11. Conveyance Allowance	As per rules of the Export Inspection Council
12. LTC	As admissible under the Govt. of India, Ministry of Home Affairs O.M No.43/1/55-Estt.(A)P.II dated the 11 th October 1966 as amended from time to time. The cost thereof will be borne by the concerned Agency.
13. Disability leave	EIA will be liable to pay leave emoluments in respect of disability leave granted to him on account of any disability incurred in and through foreign service under EIA even if such disability manifests itself after the termination of service in EIA.
14. Leave Salary and Pension Contribution	During the period of his deputation, his leave salary and pension contribution will be regulated as per rules.
15. CGEIS	He will continue to subscribe to the CGEIS and the subscription per month will be recovered from his salary and sent to his parent office regularly during the period of deputation.
16. Extraordinary Pension/Gratuity	Will be regulated as applicable to the employees of Export Inspection Agency/Council.
17. Residential Accommodation	He will be entitled to draw HP as per Rules as applicable to the employees of EIA/Council.
