ORDER

Subject: Appeal made by Shri Hasmukhbhai Shantilal Shah under Section 19 (1) of the Right to Information Act, 2005

Shri Hasmukhbhai Shantilal Shah vide his letter dated 12.08.2013 (received on 23.08.2013) has made an appeal under Section 19 (1) of the Right to Information Act, 2005 against letter dated 31.07.2013 of CPIO, EIC in respect of information sought by him vide his application dated 12.06.2013.

Vide his application-dated 12.06.2013 addressed to CPIO, DOC, Shri Hasmukhbhai had requested for five information (numbered A to E) concerning export of meat / mutton / beef / hide etc., which was transferred to CPIO, EIC for addressing part of information listed at 'A' in the application. At 'A' of his application dated 12.06.2013, Shri Hasmukhbhai had sought information relating to Meat & Hide and as EIC deals with 'Meat', the related information was furnished by the CPIO, EIC to him vide letter dated 31.07.2013.
