### ORDER

**Subject: Appeal made by Shri Parveen Kumar under Section 19 (1) of the Right to Information Act, 2005.**

Shri Parveen Kumar vide his letter dated 08.08.2013 has made an appeal under Section 19 (1) of the Right to Information Act, 2005 against letter dated 27.05.2013 of CPIO, EIA – Delhi in relation to information sought by him vide his application dated 06.06.2013.

Shri Kumar, vide his application-dated 06.06.2013, had sought information concerning issue of COOs under ISFTA & ITFTA and related physical verifications carried out, in the given format, for the period 01.01.2013 – 31.03.2013 and in reply vide his letter dated 27.05.2013, the CPIO, EIA – Delhi had allowed inspection of records as the information sought did not exist in the format given by the applicant. The present appeal has been preferred by Shri Kumar claiming that the CPIO after allowing inspection of records is not giving any date/time for the same in spite of his request.

The appeal filed by Shri Parveen Kumar stands disposed of with the direction to CPIO, EIA – Delhi to arrange for inspection of related records (as per his letter dated 27.05.2013) by Shri Parveen Kumar and inform him the date/time on which he can carry out the inspection within 4 weeks of receipt of this order.
