#### ORDER


**Subject: Appeal made by Shri Praveen Sakhuja under Section 19(1) of the Right to Information Act, 2005**

Shri Praveen Sakhuja vide his letter dated 20.05.2013 has made an appeal under Section 19(1) of the Right to Information Act, 2005 against reply dated 10.05.2013 of CPIO, EIC in relation to information sought by him vide his application dated 12.04.2013.

Vide his application-dated 12.04.2013, Shri Praveen Sakhuja had sought address of four officials. In reply, the CPIO, EIC vide his letter-dated 10.05.2013 had denied the information invoking section 11 and 8(1)j of the RTI Act.

I have gone through the appeal filed by Shri Sakhuja and observe that he had filed similar application with CPIO, EIA – Delhi who had provided him the information in respect of one retired official. It is also observed that the above officials have since retired from service of EIA – Delhi and that they are entitled to their privacy. Further, Shri Sakhuja has not been able to bring out any larger public interest that will be served by disclosure of such information.

Accordingly, the appeal made by Shri Praveen Sakhuja stands disposed of without any further instruction to CPIO.
