Subject: Appeal made by Shri V. N. Narayanan Nair under Section 19 (1) of the Right to Information Act, 2005


Shri V. N. Narayanan Nayar, vide his e-mail dated 01.11.2012, has made an appeal under Section 19 (1) of the Right to Information Act, 2005 against letter dated 01.10.2012 of CPIO, EIC in relation to information sought by him vide his application dated 05.09.2012.

Vide his application-dated 05.09.2012, Shri Narayanan Nair had requested for following information in respect of management of pension fund by LIC of India.

- Bye-laws of the trust,
- Details of trustees,
- MOU with LIC, and
- Fund remitted to LIC for distribution of pension.

In response, while providing the information at b) & d) vide letter dated 01.10.2012, CPIO – EIC had informed Shri Nair that the remaining information was not available.

I have gone through the appeal and observe that the required information ought to be available with the concerned section. The CPIO is therefore directed to revisit the case of Shri Nair and provide him, within 15 days of this order, the information listed at a) and c) of his application dated 05.09.2012.
