### ORDER


**Subject: Appeal made by Shri Praveen Sakhuja under Section 19 (1) of the Right to Information Act, 2005**

Shri Praveen Sakhuja vide his letter dated 16.04.2012 has made an appeal under Section 19 (1) of the Right to Information Act, 2005 against against letter dated 10.04.2012 of CPIO, EIC in relation to information sought by him in his application dated 28.02.2012.

Vide his application-dated 28.02.2012, Shri Praveen Sakhuja had asked for 3 information in respect of tours undertaken by Shri Rajiv Raizada, Additional Director, EIC to the five EIAs namely (i) details of visit during the period 01.04.2011 to 31.12.2011, (ii) copies of tour programme and (iii) copies of TA bills settled by the office. In response, Shri Sakhuja was informed of (i) the period of tour and the EIA / Sub Offices visited, (ii) the authority that had approved the tour of Shri Raizada and (iii) the total expenditure that was incurred on the tour (excluding air ticket cost). Copies of tour programme and the TA bills were denied in terms of section 8 (1) (j) of the RTI Act. Shri Sakhuja has filed present appeal claiming that tour to sub offices was concealed and has demanded that CPIO be directed to supply copies of tour programme and TA bills to him.

I have gone through the appeal made by Shri Sakhuja and observe that all information having any relationship to any public activity or interest was furnished by the CPIO. In case Shri Sakhuja has any information that details of tour undertaken to a Sub Office have not been disclosed, he may supply the information to this office for initiating appropriate administrative action in the matter.

As there is no denial of information, the appeal filed by Shri Sakhuja stands disposed off.
