### ORDER

**Subject: Appeal made by Shri Parveen Kumar under Section 19 (1) of the Right to Information Act, 2005.**

Shri Parveen Kumar vide his letter dated 07.12.2012 has made an appeal under Section 19(1) of the Right to Information Act, 2005 against CPIO, EIC for not providing information sought by him vide his application dated 05.10.2012.

Vide his letter-dated 05.10.2012; Shri Kumar had requested for information concerning (i) date of DPC and (ii) benchmark prescribed by the DPC for the DPCs held in the year 2010, 2011 & 2012 for promotion to the post of Assistant Director (Tech). Shri Kumar had also requested for a copy of note sheets containing DPC recommendations and has filed the present appeal claiming that the CPIO, EIC has not furnished the information.

In case application filed has not yet been disposed of, the CPIO, EIC is directed to process the application-dated 05.10.2012 of Shri Parveen Kumar as per rules within 15 days of this order. In case the application has already been disposed of, the CPIO, EIC is directed to furnish a copy of his reply to the applicant within 7 days of this order.
