ORDER

Subject: Appeal made by Shri Praveen Sakhuja under Section 19 (1) of the Right to Information Act, 2005

Shri Praveen Sakhuja vide his letter dated 07.01.2013 has made an appeal under Section 19 (1) of the Right to Information Act, 2005 against CPIO, EIC in relation to the information sought by him vide his application dated 08.10.2012.

Vide his application-dated 08.10.2012 filed with EIA-Delhi, citing some leaf of attendance register, Shri Praveen Sakhuja had sought information in respect of marking of attendance by one officer of EIC. This application was forwarded by EIA-Delhi to CPIO, EIC who, informed Shri Sakhuja that the leaf of attendance register was not found with his application. Now Shri Sakhuja has filed this appeal claiming that even though he had provided a copy of the leaf of attendance sheet to the CPIO vide his letter dated 11.10.2012, the CPIO failed to provide the information sought by him vide his application dated 08.10.2012.

I have gone through the appeal made by Shri Sakhuja and direct CPIO, EIC to process his application-dated 05.10.2012 as per rules within 15 days of this order. In case the application has already been disposed of, the CPIO, EIC is directed to furnish a copy of his reply to the applicant within 7 days of this order.
