#### ORDER

**Subject: Appeal made by Shri Praveen Sakhuja under Section 19(1) of the Right to Information Act, 2005**


Shri Praveen Sakhuja vide his letter dated 01.04.2013 has made an appeal under Section 19(1) of the Right to Information Act, 2005 against letter dated 25.03.2013 of CPIO, EIC in relation to information sought by him vide his application dated 26.02.2013.

Vide his application dated 26.02.2013 Shri Praveen Sakhuja had sought four information related to status of DD (NT) working in EIC & the EIAs as on 31.12.2012. The present appeal has been made as he is not satisfied with the information furnished by the CPIO vide his letter dated 25.03.2013.

I have gone through the appeal filed by Shri Sakhuja and in the spirit of RTI, direct the CPIO - EIC to provide the following information to Shri Sakhuja within 15 days of receipt of this order.

1. Names of organisations (EIC / EIAs) where post of DD (NT) was vacant as on 31.12.2012.
2. Names of organisations (EIC / EIAs) where post of DD (NT) was occupied as on 31.12.2012 including whether the posts were occupied by fresh recruits or promotes.
3. In case of posts occupied by fresh recruits, date of advertisement, date of their application and the date of their interview.
4. Details of posts filled on deputation basis in EIC / EIAs during 01.01.2010 till the date of his application, which is 26.02.2013, including post, date of advertisement, name, date of interview and tenure of appointment.
