#### ORDER


**Subject: Appeal made by Shri Praveen Sakhuja under Section 19(1) of the Right to Information Act, 2005**

Shri Praveen Sakhuja vide his letter dated 01.04.2013 has made an appeal under Section 19(1) of the Right to Information Act, 2005 against letter dated 25.03.2013 of CPIO, EIC in relation to information sought by him vide his application dated 25.02.2013.

Vide his application-dated 01.04.2013, Shri Praveen Sakhuja had sought three information viz (i) number of appointments done by EIC for 5 EIAs for the post of AD (T), AD (NT) and TO during 1<sup>st</sup> January 2010 till 31<sup>st</sup> January 2013, (ii) number of posts lying vacant to be filled in during the period 1<sup>st</sup> February 2013 to 31<sup>st</sup> March 2013 for posts of AD (Tech) and TO for 5 EIAs and (iii) number of employed AD (T), AD (NT) and TO during the above period at '(i)' has resigned from the post during period 1<sup>st</sup> January 2010 to 31<sup>st</sup> January 2013. In reply, vide his letter-dated 25.03.2013, the CPIO - EIC had informed Shri Sakhuja that the information sought is not clear.

I have gone through the appeal filed by Shri Sakhuja and in the spirit of RTI, direct the CPIO - EIC to provide the following information to Shri Sakhuja within 15 days of receipt of this order.

1. Number of appointments made by EIC for the posts of AD (T), AD (NT) and TO during 1<sup>st</sup> January 2010 till 31<sup>st</sup> January 2013,
2. Number of posts of AD (T) and TO that fell vacant during 1<sup>st</sup> February 2013 to 31<sup>st</sup> March 2013 but were not filled up and
3. Number of AD (T), AD (NT) and TO appointed during 1<sup>st</sup> January 2010 till 31<sup>st</sup> January 2013 who resigned from their post.
