### ORDER


**Subject: Appeal made by Shri Praveen Sakhujia under Section 19 (1) of the Right to Information Act, 2005**

Shri Praveen Sakhujia vide his letter dated 21.06.2013 has made an appeal under Section 19 (1) of the Right to Information Act, 2005 against CPIO, EIC for not providing information sought by him vide his application dated 22.04.2013.

Vide his application-dated 22.04.2013 submitted through EIA – Delhi, Shri Praveen Sakhujia had requested for information relating to recruitment of Seema Shukla, Balaji Waghmae & Saber Ali as Assistant Directors in EIAs.

On enquiry, it has been stated by the CPIO, EIC that the information could not be furnished as the same was not made available by concerned section.
