
Subject: Appeal made by Shri Praveen Sakhuja under Section 19 (1) of the Right to Information Act, 2005

Shri Praveen Sakhuja vide his letter dated 20.05.2013 has made an appeal under Section 19 (1) of the Right to Information Act, 2005 against CPIO, EIC for not providing information sought by him vide his application dated 18.03.2013.
