**ORDER**

**Subject: Appeal made by Shri N. K. Premi under Section 19 (1) of the Right to Information Act, 2005.**


Shri N. K. Premi, vide his letter dated 25.03.2011 has made an appeal under Section 19 (1) of the Right to Information Act, 2005 against letter dated 17.03.2011 of CPIO, EIA - Delhi in response to the information sought by Shri Premi vide his letter dated 10.03.2011.

Vide his letter-dated 10.03.2011, Shri Premi had broadly requested for information in respect of visit of Shri Bhagwan Chand Saxena to EIA - Delhi during the period Jan 2010 till 9<sup>th</sup> March 2011.

Vide his reply-dated 17.03.2011, CPIO, EIA - Delhi had denied the information under section 8 (j) [information which relates to personal information], the plea that it does not serve any public purpose.

I have gone through appeal of Shri Premi as well as the reply of CPIO, EIA - Delhi and do not agree with the contention of the CPIO, EIA - Delhi, as details of visitors to EIA - Delhi, a public office, cannot be considered as personal information.

CPIO, EIA - Delhi is therefore directed to provide information sought by Shri N. K. Premi vide his application dated 10.03.2011 within 15 days of receipt of this order.
