**Subject: Appeal made by Shri Praveen Sakhuja under Section 19 (1) of the Right to Information Act, 2005**


Shri Praveen Sakhuja vide his letter dated 18.05.2011 has made an appeal under Section 19 (1) of the Right to Information Act, 2005 against letter dated 11.05.2011 of CPIO, EIC in relation to information sought by him vide his application dated 18.04.2011.

Vide his application-dated 14.04.2011, Shri Praveen Sakhuja had requested for copies of the following in relation to the presence of Shri S. K. Tandon in the chamber of Mrs. Sushma Singh, Information Commissioner, on 13.04.2011.

- (i) Notice received from CIC,
- (ii) Document initiated for seeking permission from the public authority for Shri Tandon to visit CIC and
- (iii) Order passed by CA (PA) for Shri Tandon to visit CIC.

In response, CPIO – EIC vide his letter dated 11.05.2011 had provided Shri Sakhuja a copy of notice dated 16.03.2011 (File No: CIC/SS/A/2011.000082) received from CIC in respect of (i) above and in respect of (ii) and (iii) had informed him that no information was available on records.
