#### ORDER

**Subject: Appeal made by Shri Praveen Sakhuja under Section 19(1) of the Right to Information Act, 2005**

Shri Praveen Sakhuja vide his letter dated 15.05.2013 has made an appeal under Section 19(1) of the Right to Information Act, 2005 against reply of CPIO, EIA - Delhi in relation to information sought by him vide his application dated 22.04.2013.

Vide his application-dated 22.04.2013, Shri Praveen Sakhuja had sought information, in a format, related to appointment of three officials namely Seema Shukla, Balaji Waghmae and Saber Ali, which was furnished by the CPIO, EIA - Delhi vide letter dated 15.04.2013 (to be read as 07.05.2013). The present appeal has been lodged, as he is not entirely satisfied with the information furnished by the CPIO relating to Ms. Seema Shukla. According to him, he should also be informed of (i) year of passing BAsc & M Tech, (ii) experience broken up in three parts - standardization, testing & others (iii) full form of 'DNV' and (iv) confirmation about broken spell in experience - from 04.03.2006 to 05.04.2006.

I have gone through the appeal filed by Shri Sakhuja and observe that whereas (ii) and (iv) may involve interpretation, information in respect of (i) & (iii) would be available in the application filed by Seema Shukla. Accordingly, CPIO EIA - Delhi is hereby directed to provide information corresponding to (i) & (iii) above to Shri Praveen Sakhuja within 15 days of receipt of this order.
