#### ORDER

**Subject: Appeal made by Ms. KR Chandrika under Section 19(1) of the Right to Information Act, 2005**

Ms. KR Chandrika vide her letter dated 29.05.2013 has made an appeal under Section 19(1) of the Right to Information Act, 2005 against letter dated 10.05.2013 of CPIO, EIA – Kochi in relation to information sought by her vide application dated 25.04.2013.

Vide her application-dated 25.04.2013, Ms. Chandrika had sought information related to pension and medical benefit payable to her consequent to her retirement from EIA – Kochi, which was furnished by the CPIO, EIA – Kochi vide letter dated 10.05.2013. The present appeal has been preferred as she is not satisfied with the information furnished by the CPIO for serial B of her application.

Vide serial B of her application, Ms. Chandrika had requested for copy of monthly pension calculation working sheets detailing the components due to her, from February 2008 till March 2013. In response, the CPIO had provided her copies of two PPOs dated 15.01.2008 & 27.03.2009, informing him that the required information is contained in those documents. The CPIO has also clarified that while the available information was provided, further details could not be provided as the pension is actually being disbursed through the Life Insurance Corporation of India.

I have gone through the appeal filed by Ms. Chandrika and observe that she superannuated from the services of EIA – Kochi on 31<sup>st</sup> January 2008; that it is the responsibility of EIA – Kochi to pay her pension and other benefits as ordered by the competent authority from time to time and that she is within her rights to know whether she has been paid the benefits as ordered or not. It was therefore the responsibility of EIA – Kochi to ascertain the details from LIC, the outsourced agency for disbursement of pension, the details desired by Ms. Chandrika.


The CPIO, EIA – Kochi is therefore directed to provide, within one month of receipt of this order, the information detailed on the next page to Ms. KR Chandrika [beginning with the month of Feb 2008 (payable on 01.03.2008) and ending with the month of March 2013 (payable on 01.04.2013)] after collecting it from LIC of India.
