Shri Praveen Sakhuja vide his letter dated 18.03.2013 has made an appeal under Section 19(1) of the Right to Information Act, 2005 against letter dated 06.03.2013 of CPIO, EIC in relation to information sought by him vide his application dated 07.02.2013.

Information sought by Shri Sakhuja vide his application-dated 07.02.2013 and provided by CPIO, EIC vide his letter dated 06.03.2013 was as under:


Shri Sakhuja has filed the appeal demanding clear information in respect of sub point 1 to 3 & 5 and copy of NOC (point 3).

The CPIO, EIC is therefore directed to inform Shri Sakhuja, in clear terms, within 15 days of receipt of this order whether or not Shri Kanan Kasturi was complying with the requirements detailed at sub point 1 to 3 of point 1 above.
