ORDER

Subject: Appeal made by Shri B. C. Saxena under Section 19 (1) of the Right to Information Act, 2005.

Shri B. C. Saxena vide his letter dated 28.06.2011 has made an appeal under Section 19 (1) of the Right to Information Act, 2005 against the decision dated 16.06.2011 of CPIO, EIC for not providing complete information requested by him vide his application dated 27.05.2011.


Vide his letter-dated 27.05.2011, Shri Saxena had requested for following information in respect of tours undertaken by the Additional Director, EIC.

1. Place (s) of Tour (s)
2. Date of departure from HQ
3. Date of arrival to HQ
4. Reasons for tour, and
5. Did Director approve the tour?

In reply, the concerned section had supplied information in respect of point no. 1, 2 & 3 above and had informed that searching for information in respect of point no. 4 would involve diversion of resources of the section manned by a caretaker and a LDC as documents / vouchers relating to a period of 18 months will have to be searched.

I have gone through the records of the case and observe that the information as available on the records has been furnished by the section to Shri Saxena. Whereas I also agree with the contention of the section that searching of records generated over a period of 18 months would entail diversion of meagre resources of the section, I would also like that the very purpose for which the Right to Information Act was enacted is also ensured.

The CPIO, EIC, is therefore directed to provide Shri Saxena, within 15 days of receipt of this order, the estimated cost of collecting the remaining information from the records of 18 months and provide the information to Shri Saxena within 30 days of deposit of such cost by Shri Saxena.
