ORDER

Subject: Appeal made by Shri B. C. Saxena under Section 19 (1) of the Right to Information Act, 2005.

Shri B. C. Saxena vide his letter dated nil has made an appeal to the Chairman, Appellate Authority, Department of Commerce, against the decision dated 16.06.2011 of CPIO, EIC for not providing complete information requested by him vide his application dated 17.05.2011 addressed to the CPIO, MOC.

Vide his letter-dated 17.05.2011 addressed to the CPIO - MOC, Shri Saxena had requested for following information and certified copies of related documents in respect of Plan Funds allocated to EIC for the FY 1999 - 2000 till FY 2010 - 2011.


1. Amount allocated with communication details.
2. Amount utilised with communication details.
3. Amount carried forward to next year with communication details.

The above application was transferred to CPIO, EIC and in reply, the concerned section had supplied information in respect of the 3 points raised. In respect of the related communications, it had informed Shri Saxena that the same could not be provided as the information sought related to last 12 years and it will involve diversion of resources of the section manned by a caretaker and a LDC in locating the information.

Shri B. C. Saxena vide his letter dated 27/28.06.2011 had appealed against the decision dated 16.06.2011 of CPIO, EIC and as searching of records for last 12 years would entail diversion of resources of the section, order was passed by the FAA on 14th July 2011 directing CPIO, EIC to provide Shri Saxena the estimated cost of collecting the information from the records of 12 years and to provide the information to Shri Saxena within 30 days of deposit of the cost. In compliance to the order, vide its letter no. EIC / D (Q/C) / RTI / 2011 dated 20.07.2011, the CPIO, EIC has already informed Shri Saxena the cost to be incurred in providing the required information to him.

I have gone through the records of the case and observe that there is no denial of information on part of CPIO, EIC. Accordingly, the appeal made by Shri Saxena stands disposed off.
