
### ORDER

**Subject: Appeal made by Shri Praveen Sakhuja under Section 19 (1) of the Right to Information Act, 2005.**

Vide his letter-dated 21.10.2010, Shri Praveen Sakhuja had requested for information related to use of electronic attendance cards in EIA – Delhi, categorised in 5 heads. In response, vide letter no. EIA / DEL / RTI / 2010 – 11 dated 09.12.2010, while providing information in respect of one of the heads, demanded payment of Rs. 52/- for providing Xeroxes of documents containing information demanded by Shri Sakhuja.

Not satisfied with the above, Shri Sakhuja preferred an appeal dated 11.01.2011, requesting that the CPIO, EIA – Delhi be directed to provide him the copies of documents without any charge. I have gone through the case papers and observe that there was no denial of information on the part of CPIO and that the information sought by Shri Sakhuja does not serve any public interest.

Accordingly, I find no reason to interfere with the order of CPIO, EIA – Delhi and the appeal made by Shri Praveen Sakhuja stands disposed off.
