**Subject: Appeal made by Shri Praveen Sakhuja under Section 19(1) of the Right to Information Act, 2005**


Shri Praveen Sakhuja vide his letter dated 05.08.2013 has made an appeal under Section 19(1) of the Right to Information Act, 2005 against letter dated 18.07.2013 of CPIO, EIC in relation to information sought by him vide his application dated 21.06.2013.

Vide his application-dated 21.06.2013 filed with EIA - Delhi, Shri Praveen Sakhuja had desired to know the number of times he was directed to appear before a medical board in last 10 years and had also requested for copies of notings / correspondence / letters / within EIC and with Dr. RML Hospital. The application was forwarded to CPIO, EIC who in turn had denied the request of Shri Sakhuja for copies of documents citing Section 8(1)(h) of RTI Act 2005 as well as circular dated 04.04.2013 of CVC.

In the present appeal, Shri Sakhuja has claimed that the copy of CVC circular supplied to him was so dim that he could not read it. At the same time, he has claimed that the CVC circular referred to by the CPIO does not apply to the present case.

I have gone through the appeal filed by Shri Sakhuja and find no infirmity in the order passed by the CPIO. The appeal filed by Shri Praveen Sakhuja stands disposed of with the direction to CPIO, EIC to provide Shri Sakhuja a clean copy of the CVC circular referred to above.

This also disposes of another appeal bearing same date, concerning same subject and seeking copy of letter no. EIC / D (Q/C) / Vig. / PS-II / 2012-13 dated 29.04.2013.
