ORDER

Subject: Appeal made by Shri Praveen Sakhuja under Section 19 (1) of the Right to Information Act, 2005

Shri Praveen Sakhuja vide his letter dated 05.08.2013 has made an appeal under Section 19 (1) of the Right to Information Act, 2005 against CPIO, EIC for not providing information sought by him vide his application dated 27.05.2013.

Vide his application-dated 27.05.2013 submitted at EIA – Delhi, Shri Praveen Sakhuja had requested for information concerning Shri Anand Kishore, Consultant, EIC. On enquiry, it has been stated by the CPIO, EIC that the information could not be furnished as the same was not made available by concerned section.
