### ORDER

**Subject: Appeal made by Shri Praveen Sakhujia under Section 19 (1) of the Right to Information Act, 2005**

Shri Praveen Sakhujia vide his letter dated 05.08.2013 has made an appeal under Section 19 (1) of the Right to Information Act, 2005 against CPIO, EIC for not providing information sought by him vide his application dated 03.06.2013.

Vide his application-dated 03.06.2013 submitted at EIA - Delhi, Shri Praveen Sakhujia had requested for three information concerning appointment of veterinarians in EIC & the five EIAs. On enquiry, it has been stated by the CPIO, EIC that the information could not be furnished as the same was not made available by the concerned.
