
#### Subject: Appeal made by Shri Praveen Sakhuja under Section 19(1) of the Right to Information Act, 2005

Shri Praveen Sakhuja vide his letter dated 05.08.2013 has made an appeal under Section 19(1) of the Right to Information Act, 2005 against letter dated 28.05.2013 of CPIO, EIC in relation to information sought by him vide his application dated 08.04.2013.

Vide his application-dated 08.04.2013 filed with EIA - Delhi, Shri Praveen Sakhuja had desired to know (i) the intention of CPIO in mentioning "EIC-13-276" in his letter dated 28.05.2013 as against "EIC-13-27", (ii) the nature of information received by CPIO from deemed PIO, (iii) name & designation of deemed PIO who had supplied information to CPIO verbally. Shri Sakhuja had also requested for copies of communication received from the deemed PIOs. The application was forwarded to CPIO, EIC who in turn had provided the information to Shri Sakhuja vide his letters dated 28.05.2013 and 27.06.2013.

It is also observed that the appeal is time barred as the reply was furnished by the CPIO, EIC on 28.05.2013 and the applicant chose to file the appeal on 05.08.2013.

Accordingly, the appeal made by Shri Praveen Sakhuja stands disposed of.
