### ORDER


**Subject: Appeal made by Shri Parveen Kumar under Section 19 (1) of the Right to Information Act, 2005.**

Shri Parveen Kumar vide his letter dated 25.08.2011 has made an appeal under the Right to Information Act, 2005 against letter dated 28.02.2011 issued by CPIO, EIC in relation to information sought by him vide his letter dated 21.10.2010.

Vide his letter-dated 21.10.2010, Shri Kumar had requested for inspection of all files havinf information pertaining to a complaint lodged by him in January 2009 on reporting of Aflatoxin M1 in Milk Powder. In response, the CPIO, EIC had informed Shri Kumar that as per the concerned section, the information sought by him is not available on records.

Not satisfied with the above response, Shri Parveen Kumar has filed 2<sup>nd</sup> appeal dated 25.08.2011, stating that CPIO – EIC has deliberately falsified the information. I have gone through the case papers and observe that Shri Kumar is referring to a complaint filed in the month of January 2009, when he was not posted at EIC. Further, being a complaint, there is a possibility that it could have been processed by sections other than the one from which CPIO had sought information.

The case is therefore remitted back to CPIO – EIC with the directions that he may take a fresh look at the application dated 21.10.2010 of Shri Parveen Kumar and provide him the information, if available, within one month of receipt of this order. For this purpose, information may be obtained from the place where Shri Kumar was posted in January 2009 and also from technical, administration as well as vigilance sections of EIC.
