
ORDER

Subject: Appeal made by Shri Rajan Khanna under Section 19 (1) of the Right to Information Act, 2005

Shri Rajan Khanna, vide his letter dated 10/11.08.2011 has made an appeal under Section 19 (1) of the Right to Information Act, 2005 against orders dated 06.06.2011 & 23.06.2011 of CPIO, EIC and CPIO, EIA – Kolkata for not furnishing the entire information sought by him vide application dated 23.05.2011.

Vide his application dated 23.05.2011 (copy enclosed), Shri Khanna had sought six information in respect of his eligibility under the ACP Scheme. I have gone through the appeal made by Shri Khanna and the related records and observe that whereas the first information has been furnished by the CPIO, EIA – Kolkata, the other information requested by Shri Khanna have not been furnished to his entire satisfaction.

As proposals for grant of benefits under ACP to Group A & B employees are processed at EIC (though initiated by the respective EIAs), the case is therefore remitted back to CPIO – EIC with the directions that he may take a fresh look at the application dated 23.05.2011 of Shri Rajan Khanna and provide him the remaining information, as available, within one month of receipt of this order. For this purpose, if required, the information may also be obtained from the EIAs where Shri Khanna was posted in the related periods.
