ORDER

Subject: Appeal made by Shri Praveen Sakhuja under Section 19(1) of the Right to Information Act, 2005

Shri Praveen Sakhuja vide his letter dated 29.08.2013 has made an appeal under Section 19(1) of the Right to Information Act, 2005 against letter dated 06.06.2013 of CPIO, EIC in relation to information sought by him vide his application dated 09.05.2013.

Information sought by Shri Sakhuja vide his application-dated 09.05.2013 filed with EIA - Delhi, and the reply given by CPIO, EIC on the transferred application were as under:

Sl.	Information sought	Reply of CPIO
1.	Certified copy of the Attendance record from 1 st April to 10 th May 2013 as required to be marked by every employee of EIC/EIA-Delhi manually and through thumb impression.	Information sought is not available as Shri Rajvinder Singh is holding the additional charge of EIA-Delhi in addition to his normal duties at EIC, New Delhi and attending both offices as per work requirement.
2	Details of the leave availed for period 1 st April 2013 to 10 th May 2013 stating Earned Leave; Half Pay Leave; Medical Leave; Casual Leave or any other type of leave.	Five day medical leave during 29.04.2013 to 03.05.2013.
3.	Certified copies of the leave applications filed and availed from 1 st April 2013 to 10 th May 2013.	Certified copies of the leave application and medical advice cannot be provided collectively in terms of section 11, 8(1)(e) and 8(1)(i) of RTI Act, being third party information and has been provided in fiduciary relationship and is personal information with no public interest and disclosure of such information may cause unwarranted invasion in the privacy of the individual.
4.	If the period of leave covered with medical advice, kindly provide detail of the medical advice by providing certified copy of the medical advice.	


The present appeal has been preferred by Shri Sakhuja as he is not satisfied with the answers given at 1, 3 & 4 above. He has also raised additional queries which were not part of his RTI application.

As far as 1 is concerned, the CPIO is obliged to supply only that information that is available on records and that all the available information has been furnished to him.

As far as 3 & 4 above are concerned, there is no infirmity in the order passed by the CPIO as the documents contain personal information and the applicant has not been able to demonstrate any public interest that is likely to be served.

Accordingly, the appeal made by Shri Praveen Sakhuja stands disposed of.
