Subject: Appeal made by Shri Praveen Sakhuja under Section 19(1) of the Right to Information Act, 2005

Shri Praveen Sakhuja vide his letter dated 18.03.2013 has made an appeal under Section 19(1) of the Right to Information Act, 2005 against reply – dated 19.02.2013 of CPIO, EIA-Delhi in relation to information sought by him vide his application dated 08.03.2013.

Vide his application-dated 08.03.2013, Shri Sakhuja had sought information on 7 points relating to use of staff car and his present appeal is in respect of information furnished against points 2, 3, 6 & 7 of his application, as detailed hereunder:

Sl.	Information Sought	Reply by CPIO
2	Details of officials who are entitled for use of staff car.	Officers as per staff car rules are entitled to use staff car.
3	Official nominated as Controlling officer as per staff car rules.	Under control of the administration section of EIA – Delhi.
6	Officials nominated to sign the log book as mentioned at 5, on behalf, if not signed by the officers.	Officer using the staff car has to sign the logbook or deviations as given would apply.
7	Names and designation of officials nominated by travelling officers to sign the log book on their behalf that is JD, DD (T), DD (NT), AD etc.	The information requirement is not clear.

I have gone through the appeal filed by Shri Sakhuja and the case papers and observe that the available information has been made available to Shri Sakhuja. As there is no infirmity in the order passed by the CPIO, EIA – Delhi, the appeal filed by Shri Sakhuja stands disposed of.
