Sir,


This refers to your appeal bearing number EIA-23/07-13 dated 04.09.2012 (CIC/SS/A/2012/3722) seeking directions to CPIO, EIA - Delhi to furnish information sought by you vide your application dated 25.07.2012 concerning one Delhi region Export Inspection Employees Association.

Vide your application dated 25.07.2013, you had sought (i) confirmation whether any legal notice has been served to Shri AC Dutta & Shri V Jaykumar by an advocate on behalf of the above mentioned Association, (ii) the date of receipt of the legal notice by the above named officers, (iii) the date of recognition of the above named association and (iv) confirmation if the said association has been derecognized by authorities. In reply, vide his letter dated 22.08.2012, denied the information invoking section 8 (1) (g) of the RTI Act.

I have gone through the application and observe that (i) & (ii) are vague and may not constitute as information under the RTI Act, (iii) is not readily available as it is more than 18 - 20 years old, at the same time the three employee associations that are recognised are: All India Export Inspection Agency Employees Association, Kochi; Madras Export Inspection Agency Employees Association, Chennai & The Employees Association of Export Inspection Council / Agency, Bombay and (iv) is not available on records.

With the above information, no further instructions to CPIO are required in the matter.
