
Sir,

This refers to your application bearing reference EIA-23/07 - 3 dated 24.10.2012 (CIC/SS/A/2012/3730) seeking directions to CPIO, EIA - Delhi to furnish information sought by you vide your application dated 23.07.2012 concerning visits of the Additional Director, EIC to EIA - Delhi on 19.07.2012.

Vide your application-dated 23.07.2012, you had sought confirmation of the visit of the Additional Director to EIA - Delhi on 19.07.2012 & the name / designation of employees he met and had also requested copies of relevant page of the visitors register and the recordings of the camera for 19.07.2012. In response, vide his letter dated 22.08.2012, the CPIO, EIA - Delhi had informed you that no information is available on records.

I have gone through the papers and observe that (i) the CPIO can provide information that is available on records and that (ii) it has already been informed to you earlier that the CCTV was installed in EIA - Delhi for internal security and as such its recording cannot be provided. However, in case you so desire, you may inspect the visitors register by giving three working days' notice to the CPIO, EIA - Delhi.
