### ORDER


**Subject: Appeal made by Shri Praveen Sakhuja under Section 19 (1) of the Right to Information Act, 2005**

Shri Praveen Sakhuja, vide his letter dated 29.09.2011, has made an appeal under Section 19 (1) of the Right to Information Act, 2005 against letter dated 22.09.2011 of CPIO, EIC in relation to information sought by him vide his application dated 05.09.2011.

Vide his application-dated 05.09.2011, Shri Praveen Sakhuja had requested for copies of the CTE reports submitted by EIA – Delhi to EIC from 2006-2007 to 2009-1010 for the work of renovations and interior designing of EIA – Delhi.

In response, CPIO – EIC vide his letter dated 22.09.2011 had informed Shri Sakhuja that CTE Reports for the quarter ending March 2008, June 2008 and March 2010 are not available and that copies of 28 pages of CTE Reports for remaining period can be obtained on submission of Rs. 58/-.

I have gone through the appeal made by Shri Sakhuja and observed that there is no denial of information on the part of CPIO, EIC. The appeal made by Shri Praveen Sakhuja, therefore, stands disposed off.
