
Subject: Appeal made by Shri Praveen Sakhuja under Section 19 (1) of the Right to Information Act, 2005

Shri Praveen Sakhuja, vide his letter dated 14.10.2011, has made an appeal under Section 19 (1) of the Right to Information Act, 2005 against letter dated 30.09.2011 of CPIO, EIA - Delhi in relation to information sought by him vide his letter dated 29.09.2011.

Vide his application-dated 16.08.2011, Shri Praveen Sakhuja had requested for certain details for hiring of services of Consultant Architect Interior Designer - cum - Government Approved Valuer. While providing the information, CPIO, EIA - Delhi had offered for the inspection of related documents, which was undertaken by Shri Sakhuja on 29.09.2011. After the inspection of document, Shri Sakhuja had requested for copies of certain documents. At this stage, request of Shri Sakhuja was rejected by the CPIO, citing clause 8 (1) (h) of the RTI Act.

On enquiry, it has been stated by the CPIO that certain investigation has since been initiated and that providing the information at this juncture may impede the investigation.

As providing of information may impede the process of investigation, I do not find any justification in amending the order of the CPIO, EIA - Delhi. The appeal made by Shri Praveen Sakhuja, therefore, stands disposed off.
