Subject: Appeal made by Shri Praveen Sakhujia under Section 19(1) of the Right to Information Act, 2005

Shri Praveen Sakhujia vide his letter dated 01.04.2013 has made an appeal under Section 19(1) of the Right to Information Act, 2005 against letter dated 18.03.2013 of CPIO, EIA-Delhi in relation to information sought by him vide his application dated 14.03.2013.

Information sought by Shri Sakhujia vide his application-dated 14.03.2013 and provided by CPIO, EIA - Delhi vide his letter dated 18.03.2013 was as under:

1	On which date Shri Chauhan re-joined duty in EIA-Delhi after being relieved on 1 st September 2009.	No information on records.
2	Copy of the documents/file/noting/correspondence based on which Shri Chauhan is allowed to re-join in EIA-Delhi	No records in respect of item at 1 above.
3	Working tenure period of Group A employee, as in the transfer policy framed and approved by MOC	No information on records.
4	Copy of document/file/noting/correspondence based on which Shri Chauhan is still working in EIA-Delhi	Shri Chauhan is working in EIA Delhi based on his orders of posting.
5	Details of other Group A officers who have crossed the time / period limit of their stay in EIA-Delhi as required in transfer policy	No such list exists at EIA-Delhi.

I have gone through the appeal filed by Shri Sakhujia and observe that the information at 1, 2 & 4 above ought to be available in the service book / personal file of Shri Chauhan. Similarly, information at 3 & 5 above should also be available with EIA - Delhi in one or the other form. The CPIO, EIA - Delhi is therefore directed to revisit the application dated 14.03.2013 of Shri Sakhujia and provide him the information within 15 days of receipt of this order.
