### ORDER

**Subject: Appeal made by Shri B. C. Saxena under Section 19 (1) of the Right to Information Act, 2005.**


Shri B. C. Saxena vide his letter dated 09.11.2011 has made an appeal under Section 19 (1) of the Right to Information Act, 2005 against letter dated 28.10.2011 of CPIO, EIA – Delhi for not providing information requested by him vide his application dated 29.09.2011.

Vide his letter-dated 29.09.2011, Shri Saxena had requested for the following:

1. Certified copy of rule of law four new recruits were relieved from duty to rejoin the same station?
2. Whether the above-described absence shall be treated as on duty or otherwise.

In response, Shri Saxena was informed by the CPIO, EIA – Delhi that the information sought by him is contained in two administrative orders / letters issued by EIC and that he is required to deposit a amount of Rs. 4/- for their copies.

Shri Saxena, in his appeal, has now requested that the CPIO, EIA – Delhi be directed to provide him the information free of cost. I have gone through the appeal and observe that Shri Saxena, as a habit, files applications in a large numbers - in last few years, he has filed around 300 applications, forcing the department to commit its scarce resources and incur considerable cost both in terms of opportunity lost and manpower / postal cost. As there is no denial of information on part of CPIO, EIA - Delhi, the appeal made by Shri B. C. Saxena stands disposed off.
