
Subject: Appeal made by Shri Praveen Sakhuja under Section 19 (1) of the Right to Information Act, 2005

Shri Praveen Sakhuja, vide his letter dated 04.11.2011, has made an appeal under Section 19 (1) of the Right to Information Act, 2005 against letter dated 30.09.2011 of CPIO, EIA - Delhi in relation to information sought by him vide his application dated 01.09.2011.

Vide his application-dated 01.09.2011, Shri Praveen Sakhuja had requested 6 information regarding Shri M. K. Singh, Deputy Director, certified copies of orders related to him, his powers, the authority competent to delegate such powers and the original specialisation area of Shri Singh.

While providing the information vide letter dated 30.09.2011, the CPIO, EIA - Delhi had also asked Shri Sakhuja to deposit a fee of Rs. 8/- certified copies of orders related to Shri Singh. Shri Sakhuja has now contended that the CPIO has created a mess, has intentionally concealed the information and has detailed irrelevant information.

I have gone through the appeal made by Shri Sakhuja and the reply given by CPIO, EIA - Delhi and observe that there is no denial of information on the part of CPIO, EIA - Delhi. Accordingly, the appeal filed by Shri Sakhuja stands disposed off.
