### ORDER

**Subject: Appeal made by Shri Praveen Sakhuja under Section 19 (1) of the Right to Information Act, 2005**


Shri Praveen Sakhuja, vide his letter dated 04.11.2011, has made an appeal under Section 19 (1) of the Right to Information Act, 2005 against letter dated 19.10.2011 of CPIO, EIA - Delhi in relation to information sought by him vide his application dated 20.09.2011.

Vide his application-dated 20.09.2011, Shri Praveen Sakhuja had requested for the name and designation of authority who is custodian of APARs of officers of EIA - Delhi.

In his reply, CPIO, EIA - Delhi had informed Shri Sakhuja that in view of a similar application filed by him before the CPIO, EIC, the required information would be supplied by CPIO, EIC. Shri Sakhuja has now contended that the CPIO, EIA - Delhi, working hand in gloves with AA & PA, has intentionally concealed the information.

I have gone through the appeal made by Shri Sakhuja and observe that in reply to the reference made by CPIO, EIA - Delhi, the information was provided to Shri Sakhuja by CPIO, EIC vide his letter dated 20.10.2011 (copy enclosed).

As there is no denial of information, the appeal filed by Shri Sakhuja stands disposed off.
