ORDER

Subject: Appeal made by Shri Praveen Sakhuja under Section 19 (1) of the Right to Information Act, 2005


Shri Praveen Sakhuja, vide his letter dated 04.11.2011, has made an appeal under Section 19 (1) of the Right to Information Act, 2005 against letter dated 04.10.2011 of CPIO, EIA - Delhi in relation to information sought by him vide his application dated 05.09.2011.

Vide his application-dated 04.09.2011, Shri Praveen Sakhuja had requested for copies of CTE Reports for the period 2006 - 07 to 2009 - 10 for the work of renovation and interior designing of EIA - Delhi.

In his reply, CPIO, EIA - Delhi had referred to the information furnished by CPIO, EIC on the same subject and had informed Shri Sakhuja that out of the three reports mentioned as not traceable, one could be located, however, its copy cannot be furnished due to sensitivity, litigation and investigation. Shri Sakhuja has now contended that the CPIO, EIA - Delhi, working in connivance with CPIO - EIC, AA & PA, has intentionally concealed the information.

I have gone through the appeal made by Shri Sakhuja and observe that CPIO - EIC had informed Shri Sakhuja that CTE reports for 3 quarters were not available and that he is required to pay for the remaining copies of CTE reports. Further, the CPIO, EIA - Delhi has also informed Shri Sakhuja that out of the three reports, one has been located but its copy cannot be furnished on account of its sensitivity, litigation and an investigation. It has also been reported by CPIO - EIC that Shri Sakhuja has not taken the copies of the CTE reports asked by him so far.

I have gone through the appeal of Shri Sakhuja. As there is no denial of information, the appeal filed by Shri Sakhuja stands disposed off.
