ORDER

Subject: Appeal made by Shri Praveen Sakhuja under Section 19 (1) of the Right to Information Act, 2005


Shri Praveen Sakhuja vide his letter dated 24.10.2013 has made an appeal under Section 19(1) of the Right to Information Act, 2005 against letter dated 17.10.2013 of CPIO, EIA - Delhi in relation to information sought by him vide his application dated 03.10.2013.

Information sought by Shri Sakhuja vide his application-dated 03.10.2013 (EIA-13-42) and supplied by CPIO vide letter dated 15.10.2013 was as under:

Sl.	Information Sought	Reply of CPIO
1	List of employees with their designation in whose case a 'Public Notice' in newspaper was inserted by EIA-Delhi in last ten years	There is no case as per available records except for one case of Shri Praveen Sakhuja.
2	Certified copy (s) of the 'Public Notice' thus inserted in newspapers by EIA-Delhi	Copy of the 'Public Notice' runs into one page kindly deposit the required fees for the same

Shri Sakhuja in his appeal has asserted that the CPIO, EIA - Delhi has deliberately tried to conceal the information and that it is in his knowledge that at least one other 'Public Notice' was inserted by EIA - Delhi in the newspapers in respect of another employee. On enquiry, it has been clarified by the CPIO, EIA - Delhi that though captioned 'Public Notice', the other advertisement was meant for the employee himself and not the public in general.

I have gone through the appeal and observe that in the first place, Shri Sakhuja had sought the "List of employees with their designation in whose case a 'Public Notice' in newspaper was inserted by EIA-Delhi in last ten years". Since it is a specific request concerning "Public Notice" advertised in the newspapers by EIA - Delhi in respect of its employees, the CPIO, EIA - Delhi is hereby directed to revisit the application-dated 03.10.2013 of Shri Sakhuja and provide him, **within two weeks of receipt of this order**, one copy of each of the advertisement published by EIA - Delhi in respect of any of its employees in the newspapers in the last ten years under caption "Public Notice".
