ORDER

Subject: Appeal made by Shri Sabyasachi Banerjee under Section 19 (1) of the Right to Information Act, 2005


Shri Sabyasachi Banerjee vide his letter dated 27.08.2013 has made an appeal under Section 19(1) of the Right to Information Act, 2005 against CPIO, EIA - Kolkata for not providing complete information sought by him vide his application submitted with EIA - Kolkata.

On enquiry, it has been informed by EIA - Kolkata that information sought by Shri Banerjee vide his application dated nil, received by them on 07.06.2013, was furnished by the CPIO, EIA - Kolkata vide his letter dated 26.07.2013. Information sought by Shri Banerjee vide his application-dated 07.06.2013 and supplied by CPIO, EIA - Kolkata vide letter dated 26.07.2013 was as under:

(iv)	Whether the said bill with cash memos had submitted original or Xerox copies?	Original.

I have gone through the appeal and observe that information sought at (ii), (iii) (a) and (iv) only have been furnished by the CPIO. Further, CPIO has not submitted any justification for denying the copy of the document at (i) above in spite of the opportunity provided vide communications dated 11.09.2013, 03.10.2013, 18.10.2013 and 07.11.2013. Accordingly, the CPIO, EIA - Kolkata is hereby directed to revisit the application and provide the following information to Shri Sabyasachi Banerjee within two weeks of receipt of this order.

- Copy of relevant note concerning reimbursement of medical claim amounting to Rs. 1,28,481/- of Shri Subir Kumar Roy (ref: point number 1 of the RTI application).
- Serial number of the bill in Docket Register (ref: point number 3 of the RTI application).
