### ORDER

**Subject: Appeal made by Shri Praveen Sakhuja under Section 19 (1) of the Right to Information Act, 2005**

Shri Praveen Sakhuja vide his letter dated 24.10.2013 has made an appeal under Section 19(1) of the Right to Information Act, 2005 against letter dated 17.10.2013 of CPIO, EIA – Delhi in relation to information sought by him vide his application dated 27.09.2013.


Information sought by Shri Sakhuja vide his application-dated 27.09.2013 (EIA-13-38) and supplied by CPIO vide letter dated 17.10.2013 was as under:

b.	Date from which the said deputy director was assigned the working as Deputy Director (Admn), kindly provide certified copy of the orders	From the date of his appointment he is working as Deputy Director (NT)
c.	Name of the officer who acted as Deputy Director (Admn) and initiated publication of "Public Notice" in newspapers – Hindustan Times, Times of India, Nav Bharat Times and others, Related to removal from service of applicant Praveen Sakhuja, JSA, EIA-Delhi on 26.09.2013	The matter cannot be treated as information under Section 2 of RTI Act 2005
d.	Kindly provide certified copy of the file noting or other documents based on which the publication issued.	The matter is not handled by EIA Delhi and hence there is no record with this office.

As per the present appeal, Shri Sakhuja is not satisfied with the information furnished at b, c & d above. I have gone through the papers and agree with the CPIO, EIA – Delhi that information sought at c & d above cannot be furnished by him as the matter was not handled by EIA – Delhi.

As far as b above is concerned, the CPIO, EIA – Delhi is hereby directed to inform Shri Sakhuja the date from which Shri Kannan Kasturi NS was assigned the work of Deputy

Director (Admn) and provide him a copy of the related order within two weeks of receipt of this order. With the above direction, the appeal filed by Shri Sakhuja stands disposed of.
