ORDER

Subject: Appeal made by Shri B. C. Saxena under Section 19 (1) of the Right to Information Act, 2005.

Shri B. C. Saxena vide his letter dated 25,05,2012 has made an appeal under Section 19 (1) of the Right to Information Act, 2005 against letter dated 16/17.05.2012 of CPIO, EIA - Delhi for not providing information requested by him vide his application dated 23.04.2012 (animal casing).

Vide his letter-dated 23.04.2012, Shri Saxena had requested for 10 information in respect of 'Animal Casing' scheme, as GS (General Secretary) of 'Delhi Region Export Inspection Employees' Association'. The letter head also claimed that the said association was recognised by the Export Inspection Council.

In response, vide letter-dated 16/17.05.2012, Shri Saxena was informed by the CPIO, EIA - Delhi that there was no such recognised association; that he was misrepresenting himself and as such, he was not eligible to receive the information.

The issue has been examined in light of the relevant laws and it is observed that Section 6 of the RTI Act deals with "request for obtaining information" and the expression "person" therein is referable to "citizen" in Section 3 of the said act. Thus it is clear that a citizen is entitled to seek information under the Act. Therefore there can be no objection to any citizen seeking information as per law. However, if someone under the garb of seeking information tries to perpetuate an illegality viz pseudo status of oneself or of the organization he perpetrates to represent, the same is not permissible under the law as law neither permits nor admits of any mischief sought to be played by any one with ulterior motive of staking his claim on that basis later on.

Since Shri B. C. Saxena has not saught the information in a straight forward manner as a citizen, as per law and is rather seeking information under a pseudonym, which is not permissible under the law (RTI Act) and is also likely to be taken undue advantage of to perpetuate the wrong, I do not find any reason to issue any further instructions to CPIO, EIA - Delhi and the appeal made by Shri B. C. Saxena stands disposed off. Shri Saxena may seek information in a straight forward manner as a citizen, without any pseudonym, as per the provisions of RTI Act.

This also disposes off his 2 other similar appeals dated 23.04.2012 (Export of Rice & Confirmation).
