
ORDER

Subject: Appeal made by Shri Praveen Sakhuja under Section 19 (1) of the Right to Information Act, 2005

Shri Praveen Sakhuja vide his letter dated 24.10.2012 has made an appeal under Section 19 (1) of the Right to Information Act, 2005 against letter dated 30.08.2012 of CPIO, EIC in relation to information sought by him vide his application dated 08.06.2012.

I have gone through the appeal made by Shri Sakhuja and observe that vide his application-dated 08.06.2012, Shri Praveen Sakhuja had requested for information relating to staff car used by the Director, EIC and had also requested for inspection of its logbook. In response, while providing the information, CPIO - EIC vide his letter-dated 13.07.2012 had informed Shri Sakhuja that the logbook can be inspected on any day with 7 day's prior notice. Further, on the request of Shri Sakhuja, CPIO had agreed for inspection of logbook on 31.08.2012. However, on 30.08.2012, the concerned section informed CPIO that due to audit, it would not be possible to produce the logbook for inspection and that the fresh date when inspection can be done would be informed in due course.

Shri Sakhuja has now filed an appeal, as he has not been informed of the date when the logbook would be offered for inspection by him. The CPIO is therefore directed to revisit the request of Shri Sakhuja and communicate to him about inspection of the logbook within 15 days of this order.
