ORDER


Subject: Appeal made by Shri B. C. Saxena under Section 19 (1) of the Right to Information Act, 2005.

Shri B. C. Saxena vide his letter dated 09.04.2012 has made an appeal under Section 19 (1) of the Right to Information Act, 2005 against CPIO, EIC for not providing information requested by him vide his application dated 28.02.2012.

Shri Saxena has claimed that vide letter-dated 28.02.2012, he had sought information relating to sanctioned strength of EIC as GS (General Secretary) of 'Delhi Region Export Inspection Employees' Association'. The letterhead also claimed that the said association was recognised by the Export Inspection Council.

On enquiry, it has been informed by the CPIO, EIC that he had not received any such application-dated 28.02.2012. Since the initial application itself has not been received, no directions can be issued to CPIO, EIA - Delhi and the appeal made by Shri B. C. Saxena stands disposed of. Shri Saxena is also advised to seek information in a straightforward manner as a citizen, without any pseudonym, as per the provisions of RTI Act. The CPIO may not be obliged to provide information sought under a pseudonym as he may not like to be a party to perpetuate an illegality viz pseudo status of yourself or of the organization you perpetrate to represent. The same is not permissible under the law as law neither permits nor admits of any mischief sought to be played by any one with ulterior motive of staking his claim on that basis later on.

This also disposes off 3 other similar appeals dated 09.04.2012 relating to foreign tours, foreign tours and documents on similar ground.
