### ORDER

**Subject: Appeal made by Shri B. C. Saxena under Section 19 (1) of the Right to Information Act, 2005.**


Shri B. C. Saxena vide his letter dated 06.12.2011 has made an appeal under Section 19 (1) of the Right to Information Act, 2005 against letter dated 21.11.2011 of CPIO, EIC for not providing information requested by him vide his application dated 24.10.2011.

Vide his letter-dated 24.10.2011, Shri Saxena had requested for the following in respect of engagement of consultants advertised vide Advertisement No. 7.

1. Name and designation of members engaged to shortlist applications.
2. Name & designation of screening committee that approved the names of candidates to be called for interview.
3. Name & designation of officer who signed the interview letters.

In response, vide letter-dated 21.11.2011, Shri Saxena was informed by the CPIO, EIC that the same cannot be disclosed as the process of engagement of consultant was not yet over.

I have gone through the appeal and observe that the information sought by Shri Saxena does not serve any public interest. Further, Shri Saxena, as a habit, files applications in a large numbers - in last few years, he has filed around 350 applications, forcing the department to commit its scarce resources and incur considerable cost both in terms of opportunity lost and manpower / postal cost. As such, I do not find any reasons to issue any instructions to CPIO, EIC and the appeal made by Shri B. C. Saxena stands disposed off.
