ORDER


Subject: Appeal made by Shri Parveen Kumar under Section 19 (1) of the Right to Information Act, 2005.

Shri Parveen Kumar vide his letter dated 03.02.2012 has made an appeal under Section 19(1) of the Right to Information Act, 2005 against PIO, EIA - Delhi for not providing information sought by him vide his application dated 13.12.2011.

Accordingly, a reference was made whereupon it has been informed by the PIO, EIA - Delhi that vide letter number EIA / DEL / RTI / 2012 / 4171 dated 02.01.2012 (copy enclosed for ease of reference), the applicant was informed that the he has to specify a period for providing the required information.

I have gone through the appeal of Shri Parveen Kumar and observe that Shri Parveen Kumar, vide his application dated 13.12.2011 had requested for (i) details of tour of Shri M. K. Singh to Agra and (ii) details of certificates issued by Shri M. K. Singh, while on tour. Whereas I agree with the PIO that first part of the information cannot be provided without specifying the period of tour, the second part of the information neither serves any public interest nor is designed to be generated by the system. I therefore find no reason to interfere with the order passed by the PIO, EIA - Delhi.
