### ORDER

**Subject: Appeal made by Shri Praveen Sakhuja under Section 19 (1) of the Right to Information Act, 2005**

Shri Praveen Sakhuja vide his letter dated 20.12.2012 (received on 15.01.2013 through DOC bearing R&I no. 58 of 14.01.2013) has made an appeal under Section 19 (1) of the Right to Information Act, 2005 against against letter dated 04.12.2012 of CPIO, EIC in relation to information sought by him in his application dated 22.10.2012.

The information sought by Shri Sakhuja vide his letter-dated 22.10.2012 filed in the office of the Commerce Secretary and the reply furnished by CPIO, EIC were as under:

a.	Details of cases in which advices are received from CVC against Shri Rajeev Raizada including the nature of action advised by CVC.	The date of advice has already been informed vide EIC's reply dated 16.10.2012 in reference to your RTI dated 17.09.2012. Details of case and nature of proceedings cannot be disclosed in terms of section 8(1)(h) of RTI Act as the matter is still with CVC and may impede the process of investigation.
b.	Designation of Disciplinary Authority of Shri Rajeev Raizada.	Information already provided vide EIC's reply dated 16.10.2012 in reference to your RTI dated 17.09.2012.
c.	Whether chargesheet has been issued to Shri Rajeev Raizada.	No.
d.	Whether any review has been made on CVC advice	Yes, information already provided vide EIC's reply dated 19.06.2012 in reference to your RTI dated 21.05.2012
e.	Whether the authority that had sought review was also the disciplinary authority for Shri Rajeev Raizada	Does not qualify to be information in terms of section 2(f) of RTI Act.
f.	Certified copy of regulations and rules containing delegation of power to the disciplinary authorities	No information on records.

I have gone through the appeal made by Shri Sakhuja and do not find any justification for further directions to CPIO as there is no denial of information on the part of the CPIO. The appeal filed by Shri Sakhuja therefore stands disposed of.

I have also observed that Shri Sakhuja, as a habit, files applications in a large number on almost all activities performed by the department including administrative / service matters related to himself, where the department has to commit its scarce resources and incur considerable cost both in terms of time lost, cost of manpower deployed and postal cost. He had earlier also sought similar information vide his applications dated 17.09.2012 & 21.05.2012 which were disposed of vide Orders dated 16.10.2012 & 19.06.2012 of the CPIO. Shri Sakhuja is therefore advised not to misuse his right to information as a tool for harassment of the department.
