
Subject: Appeal made under Section 19 (1) of the Right to Information Act, 2005 – compliance to directions issued by the CIC – reg.

Shri Praveen Sakhuja vide his letter-dated 07.03.2012 had requested the CPIO, EIC for (i) dates of visit to EIC, (ii) reasons of the visit, (iii) persons visited, (iv) period of stay in EIC on each date and (v) amount paid for each visit in respect of one Dr. Dhar, a scientist working with the Indian Institute of Integrative Medicine.

In reply, the CPIO, EIC vide his letter dated 15.05.2012 had informed the applicant that though one Dr. Dhar might have visited EIC, no information as per the format sought was available in records. Not satisfied with the answer, the applicant approached the CIC, demanding that the information be provided to him.

Now in compliance to CIC order (case no. CIC/SS/A/2012/002960), I have gone through the case papers and observe that the CPIO has furnished the available information though the applicant was not specific while seeking the information.

As there is no denial of information, the appeal of Shri Praveen Sakhuja stands disposed off without any direction to CPIO – EIC.
