ORDER


Subject: Appeal made under Section 19 (1) of the Right to Information Act, 2005 – compliance to directions issued by the CIC – reg.

Shri Praveen Sakhuja, vide letter-dated 13.02.2012, had sought details of scales of 7 posts, in a format prescribed by him, as applicable consequent to implementation of recommendations of 4th, 5th and 6th pay commissions. In response, the CPIO, EIC had provided him the information available on records vide his letter-dated 20.03.2012.

Now Shri Sakhuja vide his letter dated 21.06.2012 has made an appeal to the Central Information Commission against the Export Inspection Council for not providing certified copy and complete information requested by him vide his application dated 13.02.2012. In compliance to CIC order (case no. CIC/SS/A/2012/002978), I have gone through the case papers and observe that

- CPIO can only supply information that exists in records;
- The available information was furnished to Shri Sakhuja by CPIO, EIC vide his letter-dated 10.04.2012; and
- Shri Sakhuja, as a habit, files applications in a large number on anything and everything including administrative / service matters (whether or not they serve any public interest), where the department has to commit its scarce resources and incur considerable cost both in terms of opportunity lost, cost of manpower deployed and postal cost.

As there is no denial of information, the appeal filed by Shri Sakhuja stands disposed off. Shri Sakhuja is also advised not to misuse his right to information as a tool for harassment of the department.
