Subject: Appeal made under Section 19 (1) of the Right to Information Act, 2005 – compliance to directions issued by the CIC – reg.


Shri Praveen Sakhuja vide his letter dated 21.06.2012 has made an appeal to the Central Information Commission against the Export Inspection Council for not providing information requested by him vide his application dated 21.02.2012.

Shri Sakhuja, vide letter-dated 21.02.2012, had sought (i) details of members (names / designations / post held / office) of staff selection committee for the scrutiny of applications received for the post of JSA, (ii) copy of minutes of meeting signed by those at (i) above, (iii) details of members of SSC present for interview of the candidates and (iv) copy of minutes of meeting signed by those at (iii) above. In response, the CPIO, EIC had in general informed Shri Sakhuja, vide his letter-dated 20.03.2012, that the composition and proceedings of selection committees cannot be disclosed in terms of section 8(1)(j) of the RTI Act.

Now in compliance to CIC order (case no. CIC/SS/A/2012/002977), I have gone through the case papers and observe that

- Shri Sakhuja is not specific in seeking information and
- There is no infirmity in the decision of the CPIO in informing Shri Sakhuja that details of selection committees and their minutes cannot be disclosed.

Accordingly, I do not find any reasons to issue any instruction to CPIO: EIC and the appeal filed by Shri Sakhuja stands disposed of.
